

Standardised Price List

All funeral directors are legally required to publish this Price List for a standardised set of products and services. This is to help you think through your options and make choices, and to let you compare prices between different funeral directors (because prices can vary).

Attended Funeral (funeral director's charges only) £3120

This is a funeral where family and friends have a ceremony, event or service for the deceased person at the same time as they attend their burial or cremation.

Taking care of all necessary legal and administrative arrangements	£1305
Collecting and transporting the deceased person from the place of death (normally within 15 miles of the funeral director's premises) into the funeral director's care	£360
Care of the deceased person before the funeral in appropriate facilities. The deceased person will be kept at the funeral director's premises.	£215
Providing a suitable coffin - this will be made from basic material	£530
Viewing of the deceased person for family and friends, by appointment with the funeral director (where viewing is requested by the customer)	£35
At a date and time you agree with the funeral director, taking the deceased person direct to the agreed cemetery or crematorium (normally within 20 miles of the funeral director's premises) in a hearse or other appropriate vehicle	£675

Unattended Funeral

This is a funeral where family and friends may choose to have a ceremony, event or service for the deceased person, but they do not attend the burial or cremation itself.

Burial (funeral director's charges only)	£1640
Cremation (funeral director's charges plus the cremation fee)	£1990

Fees you must pay

For an **Attended or Unattended** burial funeral, the **burial fee**.¹

In this local area, the typical cost of the burial fee for local residents is:

£779 - £2425

For a new grave, you will also need to pay for the plot; for an existing grave with a memorial in place, you may need to pay a removal/replacement fee. In addition, the cemetery may charge a number of other fees.

For an **Attended** cremation funeral, the **cremation fee**

Terms of business

All unattended funerals will need to be paid in full before taking place. You will have 30 days from the funeral date to pay the remaining balance, failure to do so will result in 0.5% per month interest charge being added. As per our Terms & Conditions Policy.

If no payment or contact has been made within 60 days giving assurance of payment, the account will be forwarded to third party debt recovery company and additional recovery/legal costs will be incurred.
